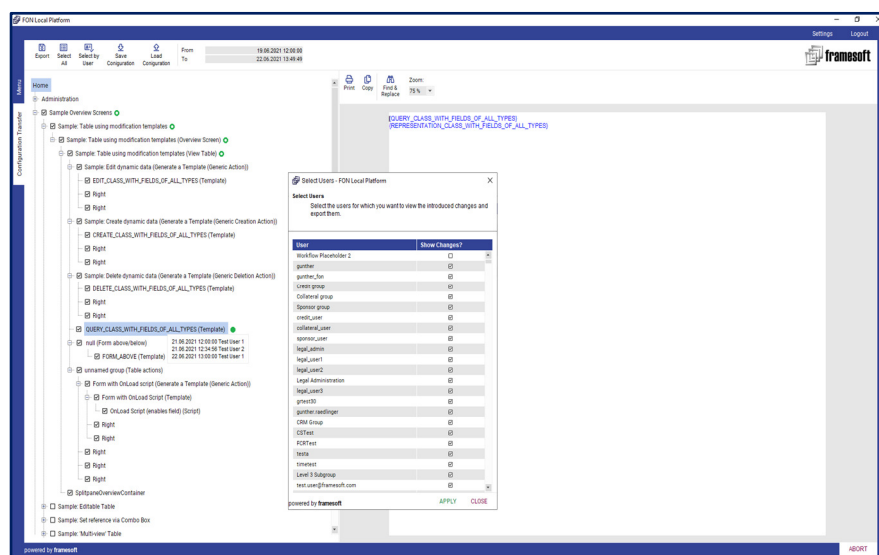
the software development, packaging, and release process by offering the following version control functionalities:

- Restoring of previous object versions

- Detail view of updated objects / components
- Automated XML export of all / selected updated components / objects
- Predefined configuration management (Save and Load predefined configurations)
