management for any kind of agreement.

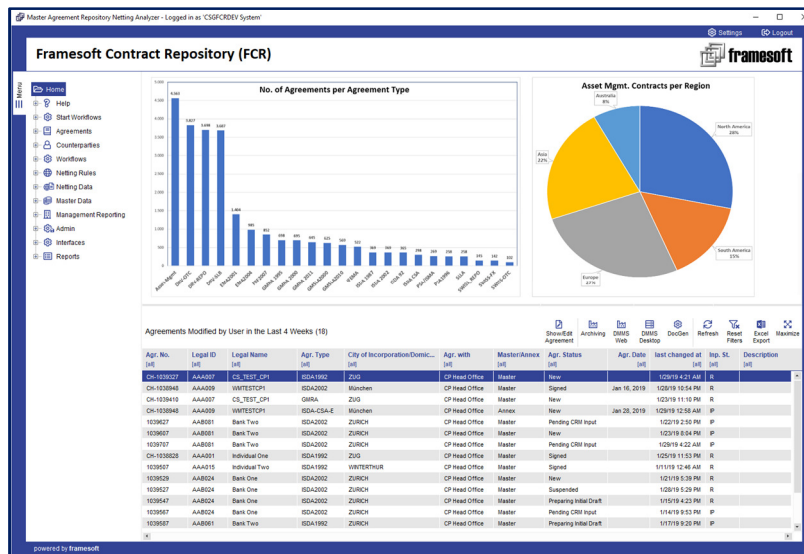

Netting & Netting Analyzer

- **Netting for Liquidation & Collateral** purposes is supported for multiple types (e.g. Internal Line Netting & Regulatory Reporting) based on fully flexible rules derived from Legal Opinions, feeding risk systems with details. FCR focuses on **automated netting decisions** based on **legal opinions & netting rules**. The netting engine scans FCR on demand or automated as a batch process to find potentially nettable combinations of customer & counterparty (on branch level) & individual product traded. FCR fully relies on configuration screens. All netting rules are adjustable at any time. This allows reacting immediately on market events.
- FCR's **netting algorithm** considers agreement data, jurisdictional legal opinions & counterparty details to calculate all nettable combinations within an agreement incl. separate netting pools within agency agreements. This allows risk systems calculating the net exposures
- **Real time netting** evaluation of single agreements, groups of agreements or a free selection of agreements via FCR Netting Analyzer module embedded in FCR.
- **FCR Netting Analyzer** offering an enhanced user interface based on modern theme & mass data analysis capabilities
- Support of **Pre-Netting checks**
